2. What Is Making Tax Digital (MTD)?

Making Tax Digital (MTD) is a long-term UK Government initiative aimed at modernising how individuals and businesses keep and report their tax records.

The goal of MTD is to replace paper-based and manual processes with systems that use digital record-keeping and software-driven submissions.

At its core, MTD introduces three main ideas:

1. Digital record-keeping

Businesses must keep certain financial information in a digital format rather than handwritten or paper-based records.

2. Use of compatible software

When a taxpayer is brought into the MTD system, they must use software that meets HMRC's technical requirements for sending updates and returns.

3. More frequent reporting

Instead of submitting figures once a year, MTD requires regular digital updates sent to HMRC through approved software.

MTD is being rolled out gradually, beginning with VAT and later expanding to other types of tax. Not all taxpayers are required to use MTD yet, and many will continue using the traditional Self Assessment process for the foreseeable future, but the overall direction is toward a fully digital tax system over time.

3. What Is MTDify Local Edition?

MTDify Local Edition is a simple, private bookkeeping system built for **one business per installation**. It provides everything a self-employed individual needs to keep clean organised bookkeeping records:

Frequently Asked Questions (FAQ)

What is "Offline-First"?

Offline-First means the software runs entirely on **your own device** — not on a cloud server, not in someone else's database, and not behind an online login.

Your data stays:

- on your computer
- in your control
- fully private
- offline
- without risk of cloud outages or breaches

Offline-First apps are becoming popular because they:

- eliminate subscription fees
- protect privacy
- give you permanent ownership of your data
- work even without an internet connection

MTDify follows this principle, so **your bookkeeping records never leave your machine** unless *you* export them.

What is MTDify?

MTDify is a simple digital bookkeeping tool for the self-employed and small businesses. It helps you keep clear, organised digital records, which is an essential habit for future MTD rules - but it does not submit tax returns or quarterly updates.

Think of it as:

"Everything you need to keep clean, digital business records without cloud apps or monthly fees."

How does MTDify Local Edition work?

MTDify runs privately on your computer using a simple local database (SQLite). When you open it:

- 1. A small window appears (your local server)
- 2. You visit it in your browser (like visiting a website, but offline)
- 3. You add income and expenses
- 4. Everything is saved locally
- 5. Dashboard updates instantly
- 6. You export CSV files at the end of the year

You do **not** need:

- cloud storage
- online accounts
- syncing
- internet access

It's similar to using a spreadsheet – just easier, faster, and better organised.

Do I need to be technical to use this?

Yes — you should be at least reasonably tech-savvy.

MTDify is designed for people comfortable with:

Starter Edition

- Runs on your local computer
- Private, offline, local-first
- Add income, expenses and categories

Ideal for hobbyists, personal accounts or to test out MTDify

Neither version connects to HMRC.

Can I try a free version before purchasing?

Yes. MTDify offers a completely free Starter Edition that allows you to try the basic features before deciding whether the Local Edition is right for you. You can download the Starter Edition from the website.

You also have an option to register for a free account (you need an account to purchase anyway) and use the online demo dashboard, which lets you explore the interface without installing anything. The demo site resets every 12 hours and is for testing only, but it gives you a clear view of how digital bookkeeping works. The Local Edition includes the full, unrestricted system for running your actual business records.

Does MTDify submit my taxes to HMRC?

No. All MTDify editions are **record-keeping tools**, not submission tools for professionals below the MTD threshold. You use it to keep accurate digital records. Tax submission is done separately using HMRC's existing tools or through your accountant.

Do you store any of my financial data?

No. Never. Your data stays entirely on:

- your computer (Starter and Local Edition)
- your server (Pro Edition once available)

We cannot access your information. We do not process or store any financial records.

Does this replace my accountant?

No - and it's not meant to. MTDify helps you keep everything tidy so your accountant can:

- reduce errors
- avoid missing expenses
- save you money
- submit accurate figures

It makes you more organised and makes their job easier.

Can I run this on more than one computer?

Yes — with limitations:

- You may install it on your own devices
- Your licence is single-user
- Your data is stored locally, so it won't sync automatically
- To move data, you export/import or copy your database file

Can I use this for multiple businesses?

NO. This software is for a single user. One business only.

Does this work offline?

Yes — fully offline. Internet is only needed for:

- downloading updates
- purchasing the product

Do I need Python?

Yes — but only for running the application. You do not need to *use* Python. The software script handles the technical bits for you.

Will this work on Windows and Mac?

Yes. You can choose one or the other when you go to buy. In the folder:

• Windows: double-click MTDifyLocal

• Mac: run MTDifyMac

• Tested across all systems

Will you help me if I get stuck?

Yes — reasonable installation support is included. Just create a support ticket through your MTDify.uk account.

Will there be updates?

Yes. You receive free minor updates (1.x.x).

Major upgrades (2.0+) can be purchased by subscription and supports the work we do.

Can I use this for clients?

Not with the standard licence. You need a **Commercial Licence** if you want to:

- host it for others
- resell it
- white-label it
- run it as a service
- use it for client bookkeeping

If my computer dies, do I lose everything?

Only if you don't make backups.

We recommend:

- Backing up the db.sqlite3 file weekly minimum or after updating your finances.
- Storing a copy in a safe location

Your data = your responsibility (Local-First principle).

Can I move my data to a new computer?

Yes — just copy your SQLite database file to the new installation.

Why is this a one-time price instead of a subscription?

Because Local-First products should be:

• Owned / private / simple

This is your software, on your device, under your control.

Can I use this if I'm not UK-based?

Yes — the tool works globally.

But the terminology is UK-focused.

Is this suitable for VAT-registered businesses?

Yes — but you will need to submit VAT manually or via your accountant.

MTDify helps you keep general bookkeeping records, but it is not MTD-compatible for VAT submissions.

Will there be a mobile app?

No – Local-First design does not rely on mobile apps.

Is this built with AI?

No – the software is a standard Django application.
